



FIRST AMENDMENT TO MEMORIAL BEND

ARCHITECTURAL REVIEW AND COMPLIANCE COMMITTEE ARCHITECTURAL GUIDELINES AS ADOPTED BY MEMORIAL BEND CIVIC ASSOCIATION, INC.

WHEREAS, that instrument entitled, "Memorial Bend Architectural Review and Compliance Committee Architectural Guidelines, September 17, 2018 Version" (the Guidelines") was previously adopted by the Board of Directors of Memorial Bend Civic Association, Inc. (the "Association") and recorded in the Official Public Records of Real Property of Harris County, Texas under Clerk's File No. RP-2018-475347; and

WHEREAS, Section 1.04(b) of the Guidelines provides for certain fees and construction deposits (the "Fees") to be charged to an Owner related to the review of plans by the Architectural Review and Compliance Committee (the "Committee"); and

WHEREAS, Section 1.04(b)(vi) of the Guidelines provides that the amount of the Fees may be changed by the Board of Directors of the Association with a majority vote; and

WHEREAS, the Board of Directors deems it in the best interest of the Association to modify Fees for certain construction projects to facilitate review by an independent architect or other professional consultant, as permitted by Section 1.04(b)(iv) of the Guidelines.

NOW THEREFORE, the Board of Directors of the Association hereby adopts the amendments to the Guidelines set forth below. In the event of a conflict between the Guidelines and this First Amendment, this First Amendment shall control. All provisions of the Guidelines not changed by this First Amendment remain valid and enforceable.

- 1. Section 1.04(b)(ii), entitled "Fee Schedule" of the Guidelines is amended to read as follows:
 - (ii) Fee Schedule. The Fees shall be as follows:

New Construction Projects:

\$750.00

Major Projects (labor and material costs over \$50,000):

\$650.00

Other Projects (labor and material costs over \$10,000 but under \$50,000):

\$250.00

Minor Projects (including but not limited to painting, fence replacement, etc.) \$100.00*

The Committee reserves the right, in its sole discretion, to classify projects as Major Projects or otherwise, without regard to project cost, in cases where the Committee determines the project scope, complexity, or other factors so require.

^{*}May be reduced at discretion of ACC.

- 2. Section 1.04(b)(iii), entitled "Construction Deposit" of the Guidelines is amended to read as follows:
 - (iii) Construction Deposit. The Owner shall submit a Construction Deposit for New Construction Projects and Major Projects. The amount of the Construction Deposit is the lesser of one percent (1%) of the total labor and materials cost for the completed project or \$4,000.00. The Construction Deposit is refundable after satisfactory final construction inspection based on a certificate of compliance and verification that no violations of the Guidelines or Declaration are outstanding. The Construction Deposit is not required to be kept in a separate account and may be deposited in the Association's general account.
